

TERMS OF USE

Thank you for visiting GirlSpring.com. These Terms of Use set forth the agreement between our website, which is owned, operated and maintained by GirlSpring, Inc. dedicated to providing teen girls with entertainment, information, games, tools, advice for a healthy and happy life.

GirlSpring, Inc. wants each visitor to our web site to have a safe, fun visit, so we have established the following terms and conditions so that you know what to expect.
